REGULATIONS OF THE CHAMPIONSHIPS - BMR 2024

1. ORGANIZATIONAL PROVISIONS: The regulations apply to the event referred to as the:

III Polish Championships in Safe Scaffolding Installation – BMR 2024

referred to in these Regulations as the **Event, Championships, or BMR 2024**.

1.1. The Regulations for the Championships – BMR 2024 (abbreviated as Regulations) are published exclusively on the website:

www.rusztowania-jurgo.pl

1.2. Correspondence can be conducted via email at bmmistrzostwa@gmail.pl and by mail to the correspondence address of one of the Organizers, **JURGO Sp. z o.o.**, Wojska Polskiego 69A/14, 10-290 Olsztyn.

2. The organizers of the event are:

3. The Director of the event is Robert Jurkiewicz, hereinafter referred to as **the Director**.

4. Honorary patronage over the event is held by:

5. The event will take place on May 17, 2024 (Friday), from 8:00 AM to 4:00 PM at the Vocational Training Center W-M ZDZ in Olsztyn, Lubelska Street 33C.

6. The event program will be posted on the website www.rusztowania-jurgo.pl.

7. EVENT OBJECTIVES

7.1. Promoting safe work at heights using scaffolding, machines and other devices.

7.2. Presenting safety standards for work at heights with the use of scaffolding.

7.3. Promoting the challenging and responsible profession of scaffolding installers in construction and honoring their hard and dangerous work.

7.4. Promoting the teaching of occupational safety and health regulations and principles for work at heights, including on scaffolding, and the use of mechanical devices and tools used on scaffolding.

7.5. Presenting good practices, preventing bad habits, and addressing situations that threaten health and safety.

7.6. Educating and raising awareness of safe work among vocational, secondary, technical, and higher education students, as well as in the professional environment of construction workers, managers, inspectors, and employers.

7.7. Exchanging experiences and building positive relationships between scaffolding installation teams from all over Poland and abroad.

7.8. Presenting the widest and most diverse range of different types and models of scaffolding used in Poland, as well as devices and tools used in scaffolding, all in one place and at one time.

7.9. Presenting devices and tools used for work on scaffolding.

7.10. Presentation of new products, technical innovations, devices, power tools, safety measures used when working at heights, related to scaffolding and working at heights.

8. ORGANIZATION RULES OF THE CHAMPIONSHIPS

8.1. PARTICIPATION RULES FOR COMPETITORS IN THE CHAMPIONSHIPS

8.1.1. In the Championships, also referred to as the Competition, in the practical part involving team competition (scaffold installers, also referred to as **Competitors**), a maximum of 30 teams can participate.

8.1.2. Participation in the Competition is confirmed by registering through the form available on the website

www.rusztowania-jurgo.pl under the BMR tab and then REGISTER as a COMPETITOR by filling out the Registration Form:

8.1.2.1. - for Polish competitors until May 5, 2024, and,

8.1.2.2. - for foreign competitors until April 14, 2024.

8.1.3. The order of form submission determines the registration.

8.1.4. The Organizer reserves the right to reject the latest entries from the province with the highest number of submissions when the maximum number of slots is filled, and a team from a province with no participants yet registers. The Organizer may add up to 5 teams from a specific province, at the expense of removing teams from a province with more than 5 submissions.

8.1.5. The Organizer allows the participation of 4 teams from abroad. The number of teams may change and depends on the Organizer and the Łukasiewicz Research Network Warsaw Institute of Technology.

8.1.6. Competitors registered on the Championship website www.rusztowania-jurgo.pl will receive a registration confirmation via email within:

8.1.6.1. 60 hours of registration - for competitors from Poland,

8.1.6.2. 100 hours of registration - for competitors from abroad.

8.1.7. If a registered Competitor does not receive confirmation according to the rules outlined in point 8.1.6., please contact the Director, Mr. Robert Jurkiewicz, at +48 501288265 or via email at bmmistrzostwa@gmail.pl.

8.1.8. Participants in the competition must:

8.1.8.1. Be at least 18 years old on the day of the Championships.

8.1.8.2. Have their own work clothes and footwear for scaffolding work.

8.1.8.3. Have current medical examinations for work at heights, covering the day of the Championships, i.e., May 17, 2024.

8.1.8.4. In the case of Polish installers, they must have qualifications as scaffolding installers issued by the Łukasiewicz Research Network Warsaw Institute of Technology in Warsaw or other institutions honored by the Łukasiewicz Research Network Warsaw Institute of Technology in Warsaw.

8.1.8.5. In the case of foreign installers, they must have:

8.1.8.5.1. Qualifications from the relevant institutions in their country of origin.

8.1.8.5.2. Additionally, confirmation of work experience as a metal scaffolding installer by the employer.

8.1.8.5.3. Personal accident insurance for the Competitor.

8.1.9. Participation in the Championships as a Competitor is subject to a fee. The entry fee is 600 PLN net for a 3-person team. The fee is mandatory and must be paid within 5 working days from the day of receiving confirmation from the Organizer about the qualification of the team, under penalty of invalidation.

8.1.10. The fee mentioned in point 8.1.9. is payable by bank transfer to the Organizer's bank account, which is the company: Jurgo Sp. z o.o., Wojska Polskiego 69A/14, 10-290 Olsztyn (NIP 7393868873), **account number 87114011110000425529001001**.

8.1.11. In case of non-payment of the fee within the required period of 5 working days from receiving confirmation, the registration of the team will be canceled.

8.2. EQUIPMENT FOR CHAMPIONSHIP COMPETITORS

8.2.1. The Championship Organizer provides certified equipment for Competitors for work at heights, including harnesses, ropes (2 pieces with carabiners), helmets, goggles, gloves, and reflective vests.

8.2.2. The Championship Organizer provides Competitors with the necessary tools for the proper installation and dismantling of scaffolding, including mounting wrenches (19mm and 22mm, known as ratchet and flat), measuring tapes, levels, hammers, and a hammer drill with an extension of max. 40 meters or a cordless hammer drill.

8.2.3. The Championship Organizer provides the necessary scaffold elements for practical and theoretical competition.

8.2.4. Competitors must provide their own protective footwear with reinforced toes and work clothing.

8.3. BMR CHAMPIONSHIP COMPETITIONS

8.3.1. The Safe Scaffolding Installation Championships consist of the following parts:

8.3.1.1. Theoretical part in the form of a test consisting of 20 questions regarding knowledge of scaffolding and occupational health and safety regulations. The team answers the questions (one test per team).

8.3.1.2. Practical part consisting of two tasks:

I. Assembly and disassembly of typical scaffolding (e.g., frame) with the construction of anchoring mesh. The type of scaffolding and the wall to be covered will be presented on the day of the competition. Competitors perform the assembly of the scaffolding structure based on their own sketch, using the necessary data received for its execution, or a sketch requiring completion, or a ready sketch received from the Organizer. They then dismantle the constructed scaffolding. The structure may be enhanced with the assembly of additional elements and equipment.

II. Assembly and disassembly of atypical scaffolding (e.g., modular) according to the received project. The type of scaffolding and the installation location will be presented on the day of the competition. Competitors assemble the

scaffolding structure based on a sketch provided by the Organizer or a sketch requiring completion by the Competitors. They then dismantle the constructed scaffolding. The scaffolding structure may be enhanced with the assembly of additional elements.

8.3.2. The Championships take place in rounds. Each round involves 6 to 8 teams simultaneously. A team consists of three Competitors. Each subsequent round begins after the previous teams leave their positions according to the schedule set by the Organizer.

8.3.3. The Organizer reserves the right to change the competitions, no later than on the day of the Championships, due to reasons beyond their control, such as adverse weather conditions and others.

8.3.4. The Championships will take place regardless of weather conditions, but in case of adverse weather conditions, they will be moved to the enclosed premises of CSB W-M ZDZ and adjusted accordingly.

8.3.5. If the competition is held indoors, the organizer may limit himself to carrying out only one task from the practical part.

8.3.6. Competitors are required to register at the Information Point before 8:30 a.m. and present original or notarized copies of:

- a) Identity document with photo and date of birth,
- b) Document entitling to work as a scaffold installer – applicable to foreign competitors,
- c) Current medical examinations authorizing work at heights – if not sent by email,
- d) Occupational accident insurance for work at heights within the European Union – applicable to foreign competitors.

8.3.7. Each team member must, before participating in the competition, sign a declaration about their health status, participation voluntarily, knowledge of the "Regulations of the BMR 2024 Championships," and consent to the use of their image and processing of personal data. There is no possibility of signing the declaration on behalf of another person.

8.3.8. NOTE: Failure to sign the declaration mentioned in point 8.3.6. of this Regulations disqualifies the Competitor from participating in the BMR 2024 Championships.

8.3.9. During the registration of Competitors at the Information Point, each Competitor will receive a starter pack, including event-related gadgets and a voucher for a meal for one-time use at the catering point.

8.3.10. The Organizer reserves the right to change the Regulations of the Championships, no later than May 16, 2024, until 12:00 a.m.

8.4. EVALUATION AND AWARDING OF POINTS TO CHAMPIONSHIP COMPETITORS

8.4.1. Theoretical part: It involves providing the correct answer in a test consisting of 20 questions. 1 point is awarded for each correct answer, and points are summed up. The team has a maximum of 45 minutes to complete the test and can earn a total of 20 points.

8.4.2. Practical part: The evaluation will focus on the completed/supplemented sketch, adherence to occupational health and safety rules during the assembly and disassembly of scaffolding, teamwork skills, work organization, method and correctness of scaffolding and additional elements and equipment assembly and disassembly, and order in the danger zone. The evaluation criterion is not time, but there is a maximum of 30 minutes allocated for each construction. Once this time is exceeded, the team finishes the competition. The Organizer assumes that 20 minutes are allocated for assembly and 10 minutes for disassembly.

8.4.3. For each correctly completed construction, the team can earn a maximum of 50 points, a total of 100 points, and for each mistake during assembly and disassembly, points are deducted. Each mistake equals -1 point.

8.4.4. The final number of points obtained is the sum of points earned in the theoretical and practical parts. The team can achieve a maximum of 120 points in total.

8.4.5. Each team member contributes to the final result of the team.

8.4.6. The number of points earned will determine the team's position in the overall classification of the Championships.

8.4.7. The Organizer allows the participation of mixed teams in the Championships - female-male, provided that each player individually meets the requirements of this regulation.

8.4.8. The Championship Judges are qualified and authorized instructors in the profession of assembling building scaffolding-metal scaffolding from the Łukasiewicz Research Network Warsaw Institute of Technology in Warsaw, as well as occupational health and safety inspectors from PIP and OSPS BHP.

8.4.9. The judging team consists of two individuals: an instructor in the trade and an occupational health and safety inspector.

8.4.10. Each competition station will be judged by a judging team, meaning that, for example, there will be eight judging teams for eight stations.

8.4.11. Disputable and doubtful situations during the allocation of points, as well as in case of filing a complaint, appeal, or objection by a team, will be resolved by a three-person Revision Commission, selected from the judges: one trade instructor, one occupational health and safety inspector, and one Organizer or a person designated by the Organizer.

8.4.12. The winner is the team with the highest number of points. In the case of teams with the same number of points, it applies exclusively to positions 1-3, and the teams enter a tiebreaker. The tiebreaker takes the form of a quiz. The Revision Commission asks questions, and the team that commits two mistakes first loses.

9. RULES FOR PARTICIPATION OF EXHIBITORS IN THE EVENT

9.1. We invite companies from the scaffolding, construction, and occupational health and safety industries, referred to as **EXHIBITORS**, to showcase their offerings through stands, exhibitions, and advertisements. During the event, the presentation should align with the thematic scope of the Championship. With the Organizer's consent, an Exhibitor may be authorized to present offerings that deviate from the Championship's thematic scope.

9.2. APPLICATION AND CONDITIONS OF EXHIBITOR PARTICIPATION IN THE EVENT

9.2.1. The Exhibitor applies to participate in the event through the tab "BMR" and then "SIGN UP" as an EXHIBITOR with the choice of Standard or Premium, filling out the registration form by May 10, 2024. The Organizer may shorten or extend the registration period.

9.2.2. The Organizer confirms the registration and acceptance of the Exhibitor's participation in the event by email within 48 hours of the Exhibitor's registration.

9.2.3. The Organizer reserves the right to refuse the Exhibitor's registration at the event without stating a reason but must notify the Exhibitor by email within 5 business days of the Exhibitor's registration.

9.3. ORDER AND CONDITIONS OF RENTAL OF EXHIBITION SPACE

9.3.1. The Exhibitor may inform the Championship Organizer of the following requirements:

- a) Connection to the electrical network with a maximum power of 230 Watts, which is included in the participation fee in the event and booth rental,
- b) Renting a tent, for an additional fee, as mentioned in point 9.4.6.

9.3.2. The Exhibitor may approach the Event Organizer with a request for custom amenities, such as additional booth equipment like tables, chairs, separate power supply, or changes in electrical power.

9.3.3. The notification of custom amenities should be included in the registration form under the "Comments" section. In case of a request after registration, it should be submitted in writing via email to the Championship Director at bmmistrzostwa@gmail.com, with the risk of invalidation. Agreements regarding custom amenities are subject to individual agreements with the Organizer and their implementation depends on the Organizer's technical and logistical conditions. Additional fees may apply to custom amenities.

9.3.4. The allocation and location of exhibition space for the booth are the responsibility of the Organizer, who allocates space considering the order of applications, the size of the ordered space, affiliation with a specific industry sector, the event's location conditions, and, to the extent possible, the Exhibitor's special requests. The Organizer may notify the Exhibitor of the exhibition space layout (booths) and location no later than May 06, 2024.

9.3.5. All electrical work and other activities related to power supply and electrical installation at the booths are carried out exclusively by persons authorized by the Championship Organizer.

9.3.6. Exhibitors are provided with exhibition space for booth setup and equipment starting from 12:00 PM on the day preceding the Event, i.e., on May 16, 2024. In the event of the need for earlier access to the Event venue, the Exhibitor must obtain the Organizer's approval.

9.3.7. Exhibitors setting up scaffolding structures are required to deliver scaffolding components seven days before the event starts along with a drawing (structural mesh).

9.3.8. Booth, exhibition, and advertising material setup must be completed by the Exhibitor by 7:00 AM on the day of the event, May 17, 2024. Any delays may result in the Organizer's intervention, for which the Exhibitor is financially responsible. All costs incurred by the Organizer due to accelerated booth, exhibition, and advertising setup are the Exhibitor's responsibility.

9.3.9. The Exhibitor must report to the Information Point and obtain the acceptance of the booth and the entire exhibition space from the Organizer by 6:00 AM on May 17, 2024. The Organizer reserves the right to specify another time for the booth, exhibition, and advertising acceptance. Acceptance is performed by an authorized representative of the Organizer.

9.4. FEES APPLICABLE TO EVENT EXHIBITORS

9.4.1. The participation of an exhibitor in the Championships is subject to a fee.

9.4.2. The amounts specified in the regulations are net values; the applicable VAT must be added.

9.4.3. Fees related to participation in the Championships:

9.4.3.1. Reservation of exhibition space:

a) Standard booth: 2000 PLN net, includes:

- ✓ Standard-sized booth*.
- ✓ Exhibitor badges allowing access to the Championship venue.
- ✓ Invitation for guests in electronic form.
- ✓ Access to electrical power (230 V) during the Championships and booth setup and teardown periods.
- ✓ Liability insurance for the exhibitor.
- ✓ Exhibitor listing (company name and contact details, product offerings, max 60 characters) in the alphabetical list of exhibitors on the Championship website.
- ✓ Exhibitor listing (company name) in product groupings on the Championship website and in the paper catalog.

b) Premium booth: 4000 PLN net, includes:

- ✓ Standard-sized booth*.
- ✓ Exhibitor badges allowing access to the Championship venue.
- ✓ Invitation for guests in electronic form.
- ✓ Access to electrical power (230 V) during the Championships and booth setup and teardown periods.
- ✓ Liability insurance for the exhibitor.
- ✓ Exhibitor listing (company name and contact details, product offerings, max 60 characters) in the alphabetical list of exhibitors on the Championship website.
- ✓ Exhibitor listing (company name) in product groupings on the Championship website and in the paper catalog.
- ✓ Setting up the structure from the exhibitor's scaffolding - a stand or a self-supporting structure.
- ✓ Invitation to a banquet for one person.
- ✓ A five-minute presentation on the exhibitor's scope of activity, with the option of extending to a five-minute booth demonstration, commented on by a presenter during the Championships.
- ✓ Suspension of advertisements in the form of banners, 2 pcs., on the premises of the BMR 2024 Championships. (* Standard booth size is 16 or 25 m² (4mx4m or 5mx5m); the number of places with a specific area is limited. The Organizer reserves the right to change the booth size related to the location of the industry group during the BMR 2024 Championships. Ordering a different exhibition space incurs an additional fee of 200 PLN net per 10 m².)

9.4.3.2. Hanging banners on the BMR 2024 Championship venue fence and/or setting up roll-ups in the seminar pavilion(s) – 100 zł net each.

9.4.3.3. Execution of a microphone-commented presentation by the event host - 500 PLN net.

9.4.3.4. Tent rental – 800 PLN net.

9.4.3.5. Participation of an additional person in the industry evening – 380 PLN net.

9.4.3.6. The space under the scaffolding structure is free of charge.

9.4.3.7. The Organizer has the right to exempt the Exhibitor from the fee or increase it when there are appropriate justified conditions.

9.4.4. Fees mentioned in point 9.4.3 must be paid by the Exhibitor by bank transfer to the Organizer's account, which is the company: Jurgo Ltd., ul. Wojska Polskiego 69A/14, 10-290 Olsztyn, NIP 7393868873, **bank account number**

87114011110000425529001001 within 5 working days, from the time of receiving confirmation as mentioned in point 9.2.2.

9.4.5. The Organizer has the right not to allow the Exhibitor to participate in the Event if the mandatory fee is not paid on time or if the Exhibitor violates the provisions of this Regulation.

9.4.4. An Exhibitor who has not been qualified to participate in the Event but has paid the fee will receive a refund of the fee within 14 working days to the account from which the payment was made to the Event Organizer.

9.4.5. The date of crediting the transfer to the Organizer's account is considered the payment date.

9.4.6. An invoice will be issued by the Organizer at the Exhibitor's request within 14 days from the date of receiving the fee (funds) and the positive qualification of the Exhibitor to participate in the Event.

9.5. EXHIBITOR WITHDRAWAL FROM EVENT

9.5.1. An Exhibitor's withdrawal from participation in the Event or ordered services must be made either via email to bmmistrzostwa@gmail.pl or in writing with confirmation sent to the Organizer's address.

9.5.2. In the event of withdrawal from participation in the Event by April 17, 2024, inclusive, the Exhibitor is obligated to pay the Organizer an amount equal to 50% of the total fee as a handling fee associated with the costs incurred by the Organizer related to the registration and retention of exhibition space.

9.5.3. In the event of withdrawal from participation in the Event after May 01, 2024, inclusive, the Exhibitor is obligated to pay the Organizer an amount equal to 100% of the total fee as a handling fee associated with the costs incurred by the Organizer related to the registration and retention of exhibition space.

10. ORGANIZATIONAL AND REGULATORY NOTES OF THE EVENT

10.1. Participants, Exhibitors, Competitors, and individuals attending the Event are obligated to adhere to the generally applicable principles, occupational health and safety regulations, as well as fire safety rules. Exhibitors, both at their booths and throughout the Event premises, are required to comply with sanitary, fire, occupational safety, and administrative regulations, as well as internal directives applicable within the Training Centre for Industry-Specific Training W-M ZDZ in Olsztyn.

10.2. Exhibitors are obliged to stay at their booths, ensure their safety, and maintain the full equipment of the booth during the Event hours. The Organizer is not responsible for items left at the Exhibitor's booth or for damages caused in the event of the Exhibitors' potential absence at the booth due to third-party actions. The Exhibitor is financially and personally responsible for any potential damages.

10.3. Exhibition stands, along with equipment, exhibits, and advertising media, must be assembled in a way that does not pose a threat to safety and public order, especially to the lives and health of individuals (participants, visitors) present at the Event and to the property located at the Championship venue.

- 10.4.** The Exhibitor must obtain the Organizer's consent to place specific equipment, such as presentation cars, sound equipment, or audio-visual equipment at the booth. The booth equipment must not hinder or prevent the operation of other booths or impede communication with participants and visitors to the Championship.
- 10.5.** Machines and devices may only be connected when equipped with all required safety elements, especially protective covers and barriers preventing unauthorized access. Starting machines and devices that do not meet safety requirements and handling them by unauthorized persons is prohibited. When demonstrating machines and devices in motion, the area designated for this purpose must be separated and adequately secured with the Organizer's consent.
- 10.6.** In justified cases, the Event Organizer may intervene in the decoration and equipment of the exhibition space (booth), particularly by removing dangerous objects and items emitting unpleasant odours, dismantling devices disrupting the work of other Exhibitors, at the Exhibitor's cost and risk.
- 10.7.** In case information about the Championship is needed, a designated Information Point, located at the Championship venue, is available to participants (Exhibitors, Competitors, Sponsors, Patrons) and visitors, open from 6:00 AM until the end of the Event.
- 10.8.** At the Event Information Point, identification badges must be collected by Competitors, Exhibitors, Staff, Honorary Guests, and Media.
- 10.9.** The Exhibitor has the right to display and advertise their products exclusively at the purchased booth, subject to compliance with the above rules.
- 10.10.** Absolute prohibitions apply on the Event premises:
- 10.10.1.** Using damaged or makeshift electrical installations, or operating electric heating devices contrary to their intended use and fire safety regulations. Leaving unsupervised devices connected to the electrical network that are not suitable for continuous operation is also prohibited.
 - 10.10.2.** Blocking access to fire-fighting equipment and tampering with fire-fighting equipment. Blocking passages and evacuation exits, corridors, hallways, staircases, and improper use of fire-fighting equipment are strictly prohibited.
 - 10.10.3.** Placing exhibits in the booth that are dangerous to all Event participants and visitors.
 - 10.10.4.** The Organizer has the right to remove and refuse entry and display of exhibits deemed dangerous.
 - 10.10.5.** Smoking is prohibited in facilities on the Event premises and throughout the entire external area unless designated and marked by the Organizer.
 - 10.10.6.** Parking of delivery vehicles with a capacity of 3.5 tons or more and trailers is prohibited. These vehicles may only be present on the premises during booth assembly and disassembly and outside Event hours with the explicit consent of the Organizer.

11. RULES APPLICABLE ON THE DAY OF THE CHAMPIONSHIP ORGANIZATION (May 17, 2024)

- 11.1.** The regulations apply during the Event, i.e., on May 17, 2024. The regulations apply to all Event participants, including Exhibitors, Competitors, Sponsors, Patrons, Guests, and all other individuals present at the Championship venue.
- 11.2.** Participation in the BMR 2024 Event is payable exclusively for Exhibitors, Competitors, and Sponsors.
- 11.3.** Minors participating in the Event are the sole responsibility of the individuals overseeing them.
- 11.4.** The consumption and bringing of alcohol, narcotics, and other intoxicating substances, glass containers, and other items posing a risk and threat to the safety of Event participants are strictly prohibited. Furthermore, the Organizer has the right to deny entry to individuals who are intoxicated, showing signs of alcohol consumption, or under the influence of psychoactive substances.
- 11.5.** Bringing pyrotechnic materials, firecrackers, fireworks, weapons, sharp tools, etc., onto the Event premises is prohibited. The Organizer reserves the right to remove any event participant who violates personal conduct standards, poses a threat to the health of other participants, and disrupts the enjoyment of the Event by others.
- 11.6.** During the Championships, each Event participant is obliged to comply with occupational health and safety regulations throughout the Event area and within a 200-meter radius of the Event, i.e., in areas adjacent to the Event.
- 11.7.** It is prohibited to take tools and materials available and used in the Championships off the Championship venue.
- 11.8.** Using tools and materials available during Championship matches for purposes other than the competition without the Organizer's consent is prohibited.
- 11.9.** Each Event participant is obliged to follow the instructions of Security, the Organizer, or the Medical Patrol and comply with the provisions of this Regulation.
- 11.10.** In case of danger, each Event participant is obliged to follow the orders given by security, the Organizer, or the medical patrol.
- 11.11.** In case of a health threat, each participant is obliged to inform the Organizer at the information point or security, the medical patrol about the imminent danger.
- 11.12.** The Organizer is not responsible for items left on the Event premises.
- 11.13.** Event participants are to use the proposed attractions only in a manner consistent with their intended purpose.
- 11.14.** Responsibility for the proper use of Event attractions lies with each participant (adult) or guardian (in the case of a minor, disabled, or other person requiring a guardian).
- 11.15.** Bringing animals onto the Event premises is prohibited.

11.16. The Organizer reserves the right to cancel or interrupt the Event in situations posing a danger to Participants, Exhibitors, Competitors, Sponsors, Patrons, and all other individuals present at the Event.

11.17. The Organizer reserves the right to use and process photos and film recordings of participants and guests for informational and promotional purposes related to the activities of BMR 2024 in accordance with the Personal Data Protection Act of August 29, 1997 (Journal of Laws of 2002, No. 101, item 926, as amended).

11.18. In accordance with Article 13 of the General Data Protection Regulation of April 25, 2018, I hereby inform you that:

a) The administrator of your personal data is JURGO Sp. z o.o. with its registered office in Olsztyn at ul. Wojska Polskiego 69A/14, hereinafter referred to as the Administrator. The Administrator processes your personal data, including:

- ✓ Full name
- ✓ Address, telephone number
- ✓ Image recorded in photos and videos

b) Your personal data will be processed for the purpose of promoting the organized event by the Administrator's services and will not be disclosed to other recipients.

c) The legal basis for processing your personal data is the consent given by you for the processing of personal data, which is concluded in a non-written form upon entering the event venue.

d) You have the right to:

- ✓ Request access to your personal data, their rectification, deletion, or limitation of processing,
- ✓ Object to such processing,
- ✓ Data portability,
- ✓ Lodge a complaint with the supervisory authority,
- ✓ Withdraw your consent to the processing of personal data.

e) Your personal data is not subject to automated decision-making, including profiling.

f) Your personal data will be stored for the duration of the service provision.

11.19. Entering the Event premises is equivalent to accepting the provisions of this Regulation and expressing consent as mentioned in point 11.17 and point 11.18.

12. FINAL PROVISIONS

12.1. The Organizer reserves the right to cancel, shorten, postpone, or partially close the Event in the event of circumstances for which the Organizer is not responsible, including the impact of force majeure, adverse weather conditions such as storms, floods, thunderstorms, snowfall, explosions, strikes, demonstrations, terrorist attacks, and other unforeseen circumstances at the stage of creating this regulation.

12.2. In the event that the Event does not take place due to reasons for which the Organizer is responsible, the Organizer will refund within 14 days 50% of the fees paid by Exhibitors, Competitors, Sponsors, Patrons to their specified bank accounts - as a preparatory cost.

12.3. In the event that the Event does not take place or the Organizer is required to shorten or reschedule the Event for reasons for which the Organizer is not responsible, as stated in point 12.1, financial and material fees paid by Exhibitors, Competitors, Sponsors, Patrons will not be refunded by the Organizer. Exhibitors, Competitors, Sponsors, and Patrons share joint responsibility with the Organizer for the non-execution of the Event due to reasons beyond their control.

12.4. The Organizer of the Championships undertakes to cover the tax costs arising from the awarded prizes for the winners of the Championships.

12.5. Matters not regulated in this Regulation are subject to the provisions of the Facility Regulations, Facility Usage Instructions, generally applicable Polish law, and the Civil Code.

12.6. In resolving any disputes, the Polish language version of this Regulation is considered binding. Polish law is the applicable law for the interpretation of the Regulation.

12.7. Any disputes between the Organizer and an Exhibitor, Competitor, Sponsor, or Patron will be settled by the court having jurisdiction over the Organizer's registered office.
